

Scan Sverige's acquisition of Lindvalls Chark AB has been completed

Scan Sverige's acquisition of Lindvalls Chark AB, which was communicated in February earlier this year, has been approved by relevant authorities and completed. The acquisition means that Scan Sverige broadens its business portfolio and consolidates its position as Sweden's leading meat and charcuterie company.

Lindvalls was founded in 1925 and offers sausages and charcuterie from Swedish farms. At the production facility in Strömsnäsbruk in Småland, the company produces approximately 8 000 tonnes of sausages each year.

Lindvalls is a well-known company with experienced and skilled employees who have extensive expertise in Swedish sausages and charcuterie. The transaction means that Scan Sverige will acquire the entire Lindvalls Chark AB operation, while intending to handle the newly acquired business as a separate business unit with continued production in Strömsnäsbruk. With this acquisition, Scan Sverige's number of employees increases to approximately 1,900.
