

Alarik Sandrup appointed new chairman of the board for the Swedish Bioenergy Association

Svenska Bioenergiföreningen (Svebio), the Swedish Bioenergy Association, has appointed Alarik Sandrup, Director of Public and Regulatory Affairs at Lantmännen, as new chairman of the board.

Alarik Sandrup was nominated for the position prior to the annual meeting and was appointed chairman of the board for the Swedish Bioenergy Association April 2nd, 2020. Sandrup replaces Karin Medin, CEO of Söderenergi.

Svebio is a commercial environmental organization and a cross disciplinary meeting place for companies, researchers, opinion leaders and decision makers with around 265 members. Sandrup has been a board member of Svebio since 2008, apart from a pause during his placement in Malawi as Programme Director of We Effect. Sandrup also holds positions in ePURE, SIANI, World Bioenergy Association, Copa-Cogeca, SBPI (Swedish Petroleum and Biofuels Institute) and KSLA (The Royal Swedish Academy of Agriculture and Forestry). Given this background, he brings extensive experience and a valuable network from his different positions within the agriculture and energy sector into his coming work as chairman of the board for Svebio.
